#### **Purpose:**

The purpose of this policy is to state Massey University's commitment to attracting and supporting students from diverse social, economic, cultural backgrounds and characteristics and capabilities by providing reasonable support to groups in the community who are under-represented in the University or who are disadvantaged in terms of their ability to attend and succeed at university.

#### Policy:

Massey University is committed to reducing barriers to participation and providing equity of access to educational opportunities for all current, prospective, and future students who meet the University's entrance requirements, irrespective of diverse characteristics such as, but not limited to, their age, belief, colour, disability, employment status, ethnic or national origin, family status, marital status, race, religion, gender, or sexual orientation.

All members of the university, including staff and students, must encourage and support equitable access, engagement, participation, and success in educational opportunities for all.

Some groups of students are more likely to have experienced one or more barriers to accessing and succeeding at Massey University, such as discrimination, marginalisation, under-representation, underachievement in school, and/or socioeconomic background. Massey University aims to support these groups, including:

- Māori students
- Pacific students
- Students with disabilities
- Men, women, and gender diverse people where there are barriers to access and success
- Students from refugee backgrounds
- Students from low socio-economic backgrounds
- Differently abled and talented students

And any other groups of students who may experience barriers to access and success.
