2. Mission Statement

4. Area of Operation & Registered Office:

Operation: Members are welcomed from all campuses including extramural students

5. Committee members (Officers):

The Officer roles are open to any club member. The Head of Accountancy School (Professor Fawzi Laswad) and the Club Mentor (Dr Hedy Huang) will select the initial committee members. From the second round onwards, committee members are nominated by the Head of Accountancy School and the Club Mentor, and to be elected by the club members once per year. Club members can express their interests in joining the committee. The following positions are to be filled (positions may be combined if necessary, and some positions may be filled by more than one member):

President: Runs meetings, co-ordinates all the functions. Report to the Club Mentor about the operation of the Club.

Treasurer: Records and delivers a summary of club meetings. Keeps track of club funds.

Communication Officers: Updates club membership details and email meeting notices. Sends letters, contact speakers etc. Liaise with both internal and external stakeholders.

Events Co-ordinator: An event-based ad hoc role. For every event run by the Club, an Event Co-ordinator will be appointed among the existing committee members.

Website Co-ordinator: Liaises with the web master and provides material to maintain a current and accurate website. Make posters for events and activities and post them via website and social media (facebook etc).

6. Meetings

The committee will have a formal monthly meeting during the semesters and will meet to discuss activities and events on a regular basis agreed by the committee members.

7. Amendments

This constitution may be amended at any time by a two-thirds vote.
