Focus

Massey Business School programmes

Level of Study

Undergraduate

Purpose

The Business Excellence Scholarship supports students enrolling in a Massey Business School undergraduate degree by providing tuition fee assistance in years two and three, as well as developmental mentoring. This scholarship recognises excellence for well-rounded students.

Value and Tenure

The value of the Business Excellence Scholarship includes:

- up to \$7,000 towards the recipient's tuition fees
- faculty mentoring
- peer mentoring
- leadership development
- community service opportunities

The tenure of the scholarship is three years.

Typical Number on Offer

Up to 20 scholarships will be offered.

Eligibility

Applicants must:

- be New Zealand citizens or permanent residents
- be transitioning to Massey University from secondary school
- be intending to enrol full-time (minimum 105 credits) in the first year of an eligible bachelor's degree programme within Massey Business School

- have attained an NCEA Level 2 Certificate with a merit endorsement or better (or equivalent qualification)
- have been the leader of a school academic or cultural group, or captain of one of the school's sports teams, or a leader within a community group or organisation

All recipients will need to meet the entry criteria for their intended degree at Massey University.

Selection Criteria

The selection is based on evidence of academic achievement as demonstrated in NCEA Level 2 or equivalent and a personal statement on the applicant's suitability to receive the Business Excellence Scholarship, with evidence of leadership and potential leadership.

Selection Committee

The scholarship is awarded by the University Scholarships Selection Committee on the recommendation of the Office of the Pro Vice-Chancellor, Massey Business School.

Conditions of the Scholarship

The tuition fee payments will be made in two equal instalments of up to \$3,500 to the Massey University Student Fee account after the official financial withdrawal date of semester one for year 2 and year 3 of the scholarship award.

The value of the award is up to \$3,500 towards tuition fees in year 2 and up to \$3,500 in year 3 of an undergraduate degree within the Massey Business School. Should the cost of the tuition fees be less than \$3,500 the scholarship value will be adjusted to reflect the lower amount.

Where a student recipient withdraws from study, any payment offered through this scholarship will not be honoured or credited for future use.

If a recipient withdraws from the approved programme and are eligible for a refund of their fees, Massey University will retain the scholarship proportion of the fee paid to the recipient.

Eligible programmes include:

- Bachelor of Business (BBus)
- Bachelor of Accountancy (BAcc)
- Bachelor of Aviation (BAv)
- Bachelor of Aviation Management (BAvMan)
- Bachelor of Communication (BC); (Communication Management, Digital Marketing, Public relations, and Journalism specialisations)

Each scholarship instalment is conditional upon successful completion (pass grade) of study in the year prior.
