Disability Assistance Dogs, Emotional Support Animals, Companion Animals and Working Dogs are permitted on campus under the following conditions but must be restrained appropriately, **and always under the direct control of their owner.** Voice command is not regarded as direct control.

Any access to the University must consider:

- That domesticated animals do not cause a nuisance or hazard on University property to any person, stock, poultry, domestic animal or protected flora and fauna,
- The potential benefits to well-being of animal companionship to an individual are considered
- The potential disruption to the university's operations,
- The welfare of the animal,
- Potential allergies & phobias of staff relating to animals,
- Aggressive behaviour of animals to an individual
- The university's duty of care under the Health and Safety at Work Act 2015

#### Scope

All Massey University staff, students and visitors to a Campus.

#### Guideline

**Students:** Students with Emotional Support or Companion animals or Disability Assistance Dogs must register with the Disability Support Services and complete the animal risk assessment and access form.

**Staff:** Massey Staff with Emotional Support and Companion animals, Disability Assistance or Working Dogs must complete the animal risk assessment and access form.

The animal risk assessment and access form covers what areas of the university the student / staff member or visitor seeks to access, emergency response requirements, vaccination records, the welfare of the animal and any cultural considerations. This assessment must be completed prior to the animal accessing any campus and is to be signed off by a Campus Occupational Health and Safety Advisor. This assessment must be reviewed on an annual basis to check the plan is appropriate and access requirements remain.

Final permission is to be granted by a person's Head of School/Department, or SLT member if required, or where an event with animals is planned, the event manager/organiser. It will consider the need, animal assessment

form and feedback of students / staff who are also working in the area.

Permission for animals to be on campus is not required in the following situations.

- i. Animals which are used for teaching and research with appropriate Massey University Animal Ethics approval and management practices are in place.
- ii. Animals which are used for teaching, farm, dairy and other activities related to the commercial enterprise of the university not covered by point (i)
- iii. Animals who are patients of the Veterinary Teaching Hospital, Companion Animal Hospital, Equine Veterinary Clinic, Farm Services Clinic, and Wildbase.

#### Behaviour of animals accessing the university:

If a dog or other animal behaves inappropriately causing injury, endangerment, intimidation, or otherwise causing distress to any person on campus the dog owner will be required to comply with instructions given by the Occupational Health, Safety & Wellbeing Team, or Security / Estates.

Dog owners are responsible for managing toileting arrangements including removing all animal faecal matter from campus.

Security will arrange for any animal found on campus that is non-compliant with the guidance document requirements and is unaccompanied or unleashed to be collected by the appropriate dog pound manager or SPCA. Any associated costs will be at the owner's expense.

Exemptions to this procedure can only be given by the Director OHS&W and the appropriate PVC/DVC or other SLT member that the animal owner reports through to.

#### **Definitions**

**Disability assistance dog** means a dog certified by 1 of the following organisations as being a dog trained to assist (or as being a dog in training to assist) a person with a disability

- a) Hearing Dogs for Deaf People New Zealand:

**Emotional Support Animals:** An emotional support animal (ESA) is a pet that provides comfort and companionship to people with mental health or psychiatric disabilities. ESAs can help reduce feelings of isolation and loneliness, which can trigger anxiety disorders.

**Companion Animals:** A companion animal is a domesticated or tamed animal that is kept as a pet and cared for by a human. Companion animals can include cats, dogs, rabbits, birds, and guinea pigs. Like ESAs, companion animals can help with mental and physical health issues and can help reduce anxiety disorders.

**Working dogs:** Working dogs are dogs used for driving or herding stock, service, pest control or dogs employed by the Police or other Government agencies. Working dogs must be registered with the local city council.
